The **finance** report was reviewed and approved after several questions were asked and explained.

Committee reports

Maintenance – Darrell reported that the Handicap gate has been repaired and that it has been very quiet in the park. Supplies purchased were paint for the benches to cover up the graffiti. Information regarding the repair of the toys has been placed on Facebook. If anyone sees older children on these toys we should tell them to get off as they are for little kids only. We need to find a supplier for toys that are commercial grade. David has material for the Park signs. He needs to find were they should go. Hours for the parks to be open are 8 A.M. to Dusk. We need to install a sign at the back entrance. As the county has said that the road work at the back entrance is done they will not be installing a stop line by the stop sign leaving our complex nor are they going to repaint the road way to show a turn lane into our complex. They also said that they will be doing a "capseal" on our roads next year, however there are members who feel this will not be sufficient in repair of the roads.

Newsletter - Virginia Klein has accepted this position. She will put a newsletter together and then give it to Albert to post.

Compliance - David and Jessica Applegreen are now taking on this position. A discussion was held as to how the compliance works and if anything is reported is the reporting kept anonymous. The answer is yes.

Events Committee: Amanda reported that about 25 children participated in the Santa Clause picture activity. It was well received. Our next activity will be Easter. There will be an Easter egg hunt on Saturday March 31st. Amanda is also looking into having a Hayride set up in December and we would possible serve hot chocolate.
